WHEREAS, Affairs of the Student Legal Council are important to the Student Body and the Undergraduate Senate

WHEREAS, The Undergraduate Senate has the means by which to promote the actions and usage of the Student Legal Council

THEREFORE, BE IT ENACTED BY THE SENATE OF THE UNDERGRADUATE STUDENT BODY AT THE UNIVERSITY OF NORTH CAROLINA AT CHAPEL HILL THAT:

Section 1. Short Title

The Short Title of this bill shall be the “CLO Transparency” Act

Section 2. Amendments to the General Statutes

Title IV

Chapter 3

Article II

Section 311: Structure of the Office of Student Legal Counsel

- A. The Office of Student Legal Counsel shall be overseen by the Undergraduate Chief Legal Officer.
 1. The Undergraduate Chief Legal Officer shall, in addition to the responsibilities, powers, duties, and authorities established by the law:
 - I. Serve as legal counsel, providing zealous and competent representation to assigned clients;
 - II. Appoint student legal counsel for cases before the Board of Elections, the courts of the Undergraduate Student Body, the Supreme Court of the Student Body, and the Office of Student Conduct when representation is requested by a party or parties;
 - III. Oversee the Office of Student Legal Counsel (OLC);
 - IV. Recruit, appoint, and train Deputy Legal Officers (DLO);
 - V. Review and investigate alleged violations brought before the Board of Elections or Supreme Court of the Student Body;
 - VI. Draft a confidentiality agreement to be agreed to by all individuals working within the Office of Student Legal Counsel;
 - VII. Be empowered to remove DLOs as deemed necessary; ~~and~~
 - VIII. Delegate power to, appoint, and remove any additional positions within the Office of Student Legal Counsel as deemed necessary; **and**

IX. Provide regular reports to The Senate

- B. The finances of the Office of Student Legal Counsel shall be managed by a Treasurer of the Office of Student Legal Counsel.
 - 1. The Treasurer of the Office of Student Legal Counsel shall be appointed by the Undergraduate Chief Legal Officer.
- C. The external affairs of the Office of Student Legal Counsel shall be managed by a Director of Outreach and Education.
 - 1. The Director of Outreach and Education shall be appointed by the Undergraduate Chief Legal Officer.
 - 2. The Director of Outreach and Education shall:
 - I. Increase awareness of Student Conduct policies among the student body, and
 - II. Promote student engagement with the Student Conduct System.
- D. The internal organization of the Office of Student Legal Counsel shall be managed by a Director of Case Management.
 - 1. The Director of Case Management shall be appointed by the Undergraduate Chief Legal Officer.
 - 2. The Director of Case Management shall:
 - I. Assign members of the Office of Student Legal Counsel to cases,
 - II. Track the status of cases being managed by the Office of Student Legal Counsel, and
 - III. Receive requests for counsel.
- E. Student Legal Counsel not provided by the Chief Legal Officer or by the Deputy Legal Officer shall be provided by Student Advocates.
 - 1. Student Advocates shall be appointed by the Chief Legal Officer or by a Deputy Legal Officer.
