**WHEREAS**, the following section was removed from USB-99-015 A Bill to Amend the Undergraduate Legislative Branch after a division of the bill.

**THEREFORE, BE IT ENACTED BY THE UNDERGRADUATE SENATE OF THE  
UNIVERSITY OF NORTH CAROLINA AT CHAPEL HILL THAT**

Section 1. The following shall be amended as follows in Title I, Chapter 6, Section 631 & Section 632 of the Student Code under *Statues Affecting Undergraduate Students*:

Section 631. Requirement after Introduction

- A. Upon the introduction of a Bill of Impeachment, the Speaker shall require each Senator, who shall be enumerated by the Articles to aver to the truth of said Articles, to acknowledge such averment and to subscribe their signature to the Bill of Impeachment.
- B. After such acknowledgment and subscription of signatures, the Speaker will open the floor for debate by the members present for no more than thirty (30) minutes.
- C. After the close of debate, the Bill of Impeachment shall be voted on. It must have a 20% affirmative vote of the full Senate and no less than 5 members to be referred onto the Rules and Judiciary Committee.

Section 632. Referral to Rules and Judiciary Committee

Should the Bill of Impeachment be referred to the Rules and Judiciary Committee, the Speaker shall require the Chairperson of such Committee to call a meeting of the Rules and Judiciary Committee within seventy-two (72) hours following and to give notice within twenty-four (24)
