Section 1. Amendments

Section 103. Districts

The following shall be the districts of the Undergraduate Senate:

1. District 1. The district shall be called On-Campus housing and shall represent all undergraduate students living in on-campus housing. The district shall be entitled to eleven (11) seats.
2. District 2. The district shall be called Off-Campus housing and shall represent all undergraduate students living in off-campus housing. The district shall be entitled to eight (8) seats.
3. District 3. The district shall be called the First Generation District and shall represent all undergraduate First Generation Students. This district shall be entitled to three (3) seats.
4. District 4. This district shall be called the Transfer District and shall represent all undergraduate Transfer Students. This district shall be entitled to two (2) seats.
5. District 5. This district shall be called the Greek Housing District and shall

represent all undergraduate students living in Greek housing. This district shall be entitled to one (1) seat.

As Undergraduate Student Government President, I have elected to veto the legislation USB-99-031, which was passed by full Senate on September 26, 2017 and delivered to my office on October 11, 2017 to amend USG Senate districts.

I appreciate the time and efforts that have gone into the development of this bill, particularly by Chair Woods, Senator Molesworth and Chair Prachith. After attending Full Senate and voicing our concerns with the bill, I was expecting some changes in the bill that had previously been added regarding senator major designation and simultaneous qualification for districts.

In order to to pass this legislation, I recommend that Section 2 be amended so that major designation is based on primary major, and not based on the choice of the student running for office.

I look forward to seeing an updated draft of this bill and working towards the best legislation for the University.
