WHEREAS, KOREAN AMERICAN STUDENTS ASSOCIATION at UNC is requesting funding;



WHEREAS, KOREAN AMERICAN STUDENTS ASSOCIATION at UNC has provided no false or misleading information in the pursuit of this funding request;
